## A selection of some cases

- Insurance dispute before the Swedish Supreme Court: Successfully represented one of Sweden’s biggest forest companies against a motor insurance insurer. The dispute arose from the so called “Sala fire”, Sweden’s largest wildfire in 40 years, which started in connection with the use of a motor vehicle used for forestry/silviculture. The case involved important principal coverage issues under EU law and Swedish law relating to motor insurance.
- Tort liability dispute before the Swedish Supreme Court: Successfully represented a Swedish bank in a case involving important principal issues relating to damages in tort.
- Insurance dispute before the Svea Court of Appeal: Successfully represented a Swedish life insurance company in a high profile dispute relating to voluntary occupational pension insurance policies.
- Insurance dispute under the SCC Arbitration Rules: Successfully represented an international insurance company in a dispute relating to an aviation insurance policy.
- Set aside proceedings before the Svea Court of Appeal: Presently representing the Republic of Italy and the Kingdom of Spain in high profile set aside proceedings of three investment treaty awards under the Energy Charter Treaty.
