The 10th anniversary conference of the AIDA Polish Branch will be an outstanding and unique international event held during the ferry cruise from Gdańsk to Stockholm on the Baltic Sea from 4 to 7 June 2022.

The conference will bring legal scholars and practitioners together, so as to explore and discuss the legal and regulatory issues concerning judicial and extrajudicial methods of dispute resolution in insurance. The event will be an opportunity to meet science with practice, integrate the environment, as well as to encourage young people to become more interested in legal and insurance issues.

## TOPICS

The conference "Judicial and extrajudicial methods of dispute resolution in insurance" should cover some of the following topics:

- overriding mandatory rules in international insurance contracts;
- jurisdiction issues in insurance matters;
- judicial resolution of insurance disputes - Polish and foreign experience;
- applicable law, uniform law and the judicial resolution of insurance disputes;
- insurance uniform law as a remedy for common court and arbitration difficulties;
- solving disputes at the stage of loss adjustment proceedings;
- ADR (alternative dispute resolution) in insurance relations;
- "The Youth panel"\*\*\* (AIDA invites students and young academics/practitioners people up to 30 years of age, unless they have a doctoral degree to submit their abstracts also within these topics) – this panel is provided in English.

Due to the international character of the conference, it will be bilingual. Therefore, we plan panels in two languages - Polish and English. For that reason it is possible to present in one of them.

The deadline to submit an abstract of max. 1800 number of characters (included spaces) for all academics, practitioners and young authors **is 16/01/2022.**

Please be informed that the organizational committee of the conference reserves the right to select papers from among the submitted abstracts. The organizational committee will inform the authors of the submitted abstracts whether the relevant abstract has been submitted and the qualified persons will be informed about being assigned to the appropriate panel of the conference.

The final effect of the conference will be the publication of a joint monograph.

We would like to inform you that authors not qualified to present a paper during the conference will be able to participate in the joint post-conference publication.
